TERMS AND CONDITIONS OF CREDIT AGREEMENT

1. All parts and service invoices, which are not paid upon presentation (the indebtedness), are due and payable by the 30th day of the month following purchase.
2. If the indebtedness is not paid within the credit terms of Western Star Trucks (North) Ltd., the Applicant agrees to pay interest on the indebtedness at a rate of two percent (2%) per month (26.8% per annum), both before and after Judgement, together with all costs incurred in the collection of the indebtedness including legal fees and disbursements on a solicitor/ client basis.
3. There are to be no deductions, holdbacks or offsets of any kind, including warranty claims, from the amount billed, unless prior written approval is obtained from Western Star Trucks (North) Ltd.
4. All payments and credits will be applied to invoices and service charges at the discretion of Western Star Trucks (North) Ltd.
5. All credit privileges are withdrawn on accounts unpaid for sixty (60) days, unless other arrangements have been made with Western Star Trucks (North) Ltd.
6. All credit privileges are withdrawn on accounts that have been inactive in excess of one (1) year.
7. In order to reinstate a credit account, payment must be received in full, including all service charges, and a new credit application/agreement must be processed.
8. All goods remain the property of Western Star Trucks (North) Ltd. until such time as the merchandise is paid in full. It is also agreed that the seller, Western Star Trucks (North) Ltd., is hereby authorized to chattel, lien, or remove its goods should this account remain in arrears over sixty (60) days.
9. Western Star Trucks (North) Ltd. reserves the right to exercise its garagekeeper's lien, or any other legal means at its disposal to collect on accounts that are in arrears without further notice to the Applicant.
10. All disputes or inconsistencies regarding invoices or statements must be reported prior to payment date of the month. If there are no issues addressed with the Accounts Receivable department or Senior Management, it will be assumed accepted and due.
11. The undersigned individual party, being a principle of the corporate customer, acknowledges that he/she are co-customers from Western Star Trucks (North) Ltd. and will be personally responsible jointly and severally with the corporate customer for any and all debts incurred as a result of this application, whether or not the invoice or work order is made out solely in the name of the corporate customer.
12. If signed electronically, the undersigned consents to the provision of information and their signature electronically.
